Information on the 'Intercultural Campus Life' preparation course

The pre-course "Inter-Culturalism and Campus-Life" takes place as a block seminar on the weekend before the first week of the semester. The pre-course brings together the students of the master's program in a block event lasting several days. Primarily it is intended to:

- a) enable the students to get to know each other as well as the lecturers and other students,
- b) prepare students for intercultural interaction in an "international classroom",
- c) familiarize students with the academic structure and standards of the FSU Jena,
- d) provide an introduction to German politics, society and culture, and
- e) promote networking and integration among students by connecting them with mentors.

The preliminary course contains the following elements in particular: In cooperation with the department "Intercultural Economic Communication", it reflects on and compares differences and similarities of academic and societal cultures, thus creating sensitivity for the challenges of an internationally recruited study program. Furthermore, the preliminary course provides an overview of the structure, organization and goals of the program, including an introduction to the teaching staff. It also offers an introduction to good scientific practice in accordance with German academic standards and the standards and guidelines of the Institute of Political Science. Eventually, the most important contact points for students on campus are presented (e.g. library, Haus auf der Mauer, International Office, Examination Office/ASPA).

Beyond the campus level, students are introduced to the political and cultural location of Jena and Thuringia. This includes visiting places of remembrance (such as the former concentration camp Buchenwald) and possible discussions with Jena and Thuringia representatives from politics and society. Moreover, each international student is also assigned a German student as a mentor.

Concludingly, in a discussion with the directors of the program at the end of the semester, the students provide critical feedback on their impressions of the first semester, the knowledge and skills they have acquired, as well as their further goals for their studies and professional life.

Content	Concentrating on international organisations, this module offers a focus on one of the programme's two key areas. It adopts a wide understanding of international organisations, including international governmental organisations such as the United Nations but also non-governmental organisations, hybrid organisational structures, and informal cooperation as further forms of global governance. Starting with the most significant theories of international institutions (e.g. rational choice institutionalism and sociological institutionalism), it examines the roles of different actors (society, member states, international bureaucracies etc.) in global governance. It also addresses central problems regarding the role of international organisations by drawing on concepts such as power, autonomy, and legitimacy in different policy areas (e.g. human rights, financing, or health). A particular focus will be on the role of international organisations in dealing with international crises. How do international organisations react to crises? Do they play a central or marginal role

	in crisis management? How do international organisations change in the light of crisis management?
Intended learning outcomes	Students will gain in-depth knowledge of research on international organisations. Assessment will focus on the independent and innovative nature of their analysis.
